THE ADRC-CW RESPONSE TO CORONAVIRUS (COVID-19) Reopening

The Aging and Disability Resource Center of Central Wisconsin (ADRC-CW) is taking precautionary steps to protect the vulnerable population it serves in Langlade, Lincoln, Marathon, and Wood counties from the coronavirus (COVID-19). The ADRC-CW's regional offices will remain closed to the public while providing quality services via phone, video conferencing and through our home delivered meal program. The ADRC-CW will continue to use precautionary measures while creating a plan to safely re-open with the Wisconsin Supreme Court's decision to invalidate the Safer at Home extension.

The ADRC-CW is working closely with the four-county health department officers and the emergency managers to maintain the highest level of safety and precaution for our customer, volunteers, and staff while providing services. The Center for Disease Control and Prevention (CDC) has identified older adults to be at a higher risk for serious illness with COVID-19.

Social distancing and the use of personal protective equipment has proven to minimize the spread of the virus. The ADRC-CW will continue to use these strategies to protect its customers, volunteers, and staff as we transition to re-opening our offices and dining sites.

The ADRC-CW will continue to closely monitor the conditions of the communities we serve and will follow the guidance from our public health officers, emergency management departments, state advisory organizations, and recommendations from the CDC when determining further actions.

The CDC and public health officers recommend that individuals consider the following self-protective measures:

- Maintain social distance of six feet
- Use a face covering or mask when social distancing cannot be maintained
- Wash hands often
- Stay home when you are sick
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash
