## MEDICARE SAVINGS PROGRAMS:

Medicare Savings Programs could pay your Medicare Part B premium, a potential savings of over \$12,000 per year. **You may qualify for Medicare Savings Programs if:**

### YOU'RE SINGLE AND

- Your assets are under \$7,860
- And your gross monthly income is under \$1,435.50

### YOU'RE MARRIED AND

- Your assets are under \$11,800
- And your gross monthly income is under \$1,939.50

## PRESCRIPTION EXTRA HELP:

The Prescription Extra Help program could help pay for your prescribed medications and protect you from the coverage gap. **You may qualify for the Prescription Extra Help program if:**

### YOU'RE SINGLE AND

- Your assets are under \$14,610
- And your gross monthly income is under \$1,595

### YOU'RE MARRIED AND

- Your assets are under \$29,160
- And your gross monthly income is under \$2,155

## SENIORCARE:

SeniorCare is a prescription drug assistance program. SeniorCare is considered creditable coverage and can be used to fill the coverage gap under Medicare Part D. **To enroll in SeniorCare:**

- You must be a Wisconsin resident.
- You must be a U.S. citizen or qualifying immigrant.
- You must be 65 years of age or older.
- You must pay a \$30 annual enrollment fee per person.
- Your assets, such as bank accounts, insurance policies, home, property, etc., are not counted.
- Your annual income determines the level of coverage (and your amount of out of pocket expense)
